

Environmental Rating Summary


Percentage of children served in child care centers and home child care settings that exhibit moderate to high quality as measured by a quality index.



The FCCERS, ECCERS and ITERS rating tools use a scoring system with a range from 1 to 7, with 1 being inadequate, 3 is minimal, 5 is good and 7 being excellent. Main areas of need improvement were in the *Activities* category; *Nature and Science* and *Active Physical Play*. Resources were shared with providers on these topics. *Parent and Staff* is another area of needed improvement.

Child Development Permit Matrix


Percentage of licensed child care providers in Mono County advancing on the Child Development Permit Matrix.



This is a snapshot of permits held at the end of the program year. In May 2011 Cerro Coso College provided a permit training. 8 STAR participants attended. 3 center base and 2 family child care providers will be entering the permit matrix and 2 center base providers will be advancing on the matrix. 9 of the 11 with no permits are Spanish speaking and due to lack of college courses in their native language we anticipate that they will not enter the permit matrix. We will continue to offer professional development for these providers.








Language Spoken In the Home





Walker Survey Averages




Parents' Ethnicity









 - **Purpose:** Assess school readiness to help determine eligibility for Summer Bridge—priority to children assessed as not kindergarten ready.
- Summer Bridge
 - **Target:** Children assessed as not kindergarten ready, and, as space provides, other incoming kindergartners
 - **Purpose:** Provide a 2 week, half-day program (in English and Spanish in Mammoth) with a certified teacher to help all children be ready for school on the first day of kindergarten.



Offer home visiting services to all families with newborn children to assess family needs, provide information and support to parents, and connect children and families to available services.

 - Of the parents assessed, 81% (N=13) reported an increase in knowledge about child development.

Tooth Tutor Program

- 15 families received a home visit from Tooth Tutor, Claudia Molina – (instruction on how to keep their child’s teeth healthy and prevent more dental caries from occurring).
- Purpose: reduce the number of new and recurring dental caries (tooth decay) in children who have already experienced a high number of caries.
- Outreach:

Strategic Plan Result Areas (Oral Health)
